PURPOSE OF DATA COLLECTION

The data that the Registered User provides to OXIGENO is collected for informational, contact, research and commercial prospecting purposes. This information will be treated with the reservation, confidentiality and security stipulated by the legislation relative to this matter.

DEFINITIONS

User: You with the simple download and use of the App or access to the Website.

Registered User: You if you create an account in the App or the Website.

Database: Set of personal data of the Users duly organized and used for the purposes that OXIGENO informs you in the "Privacy and Data Protection Policy"

ACCEPTANCE OF THIS POLICY

The User approves this Policy by checking the box next to "I have read and accept the privacy and data protection policy" found in the data compilation forms, which is an essential requirement to be able to finish the process and become a Registered User. Therefore, we suggest to the User to read this Policy carefully before checking the box mentioned above.

OF THE IDENTITY OF THE REGISTERED USER AND ACCURACY OF THE INFORMATION PROVIDED
